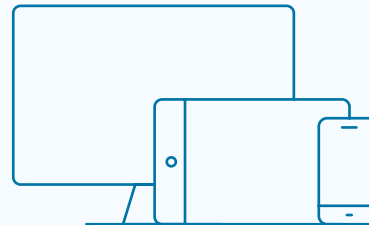

### eID NFC reading

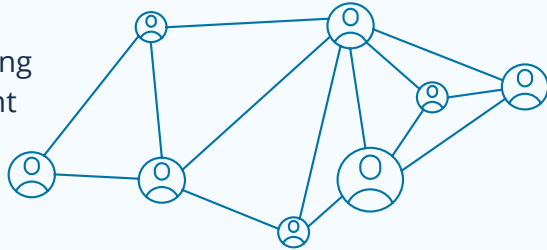
Fast and seamless identity verification by simply using an electronic document and an NFC-compatible smartphone.
